XT4 Crew Guidelines

Camp Policies, Guidelines and Expectations

These guidelines will help make *XT4 Crew* an excellent experience for everyone involved. Each camper is responsible for his/her actions and answerable to the authority of youth leaders and the *XT4 Crew* staff.

1. Be present and on time for every event - including meals, teaching sessions, and recreational activities.
2. Campers are not permitted in rooms assigned to or occupied by the opposite gender.
3. Campers are not permitted to switch recreation teams, room assignments, name tags or scheduled recreation times. If there is a conflict with scheduling, contact an *XT4 Crew* staff member.
4. Radios, Walkmans, cell phones, blackberry's, video games, laser pointers, and other electronic devices are not allowed at camp. Please leave them at home.
5. Alcohol, non-prescriptive drugs, tobacco products, firearms, fireworks, and knives are strictly prohibited from camp.
6. Please help keep the grounds as clean as possible at all times. Throw away trash and help others remember to throw away their trash instead of dropping it on the ground. *XT4 Crew Camp* and the camp grounds is our home for the week.
7. Name tags must be worn at all times. They are also a camper's pass into meals.
8. Campers should bring camp notes and writing instruments to all teaching sessions.
9. Campers should be in their assigned room by the designated time on the camp schedule. The "lights out" policy has been placed on the schedule for security reasons. Campers will not be allowed outside of their living areas after their assigned curfew.

Damages: Attending churches/individuals are financially responsible for damages to camp property. Each cabin will be issued a *Damage Report Sheet* at registration to record all pre-existing damage to your assigned living areas. The report must be turned in by Sunday night's first session at 7:00 pm. Each counselor is responsible for listing all damages found in his/her group's living areas (including, but not limited to, stains on the carpet, holes in the walls, broken screens, beds, doors, windows, etc). All unrecorded damages found after the church has left the camp ground will be billed to the church/individual on a financial statement stating the damage and the cost.

Injuries: Counselors are responsible forgetting the proper medical needs of his/her campers through the camp nurse. First Aid will be administered by the camp nurse -please do not take on this responsibility by yourself. All injuries are to be reported immediately to (1) camp nurse; (2)*XT4 Crew* staff member. Each camper must use his/her own personal insurance policy or a policy through the church. While *XT4 Crew* staff will always assist with medical emergencies, **we do not provide insurance coverage.**

Room Keys: Room keys will not be available.

Youth Pastors/leaders: Due to the number of students and the limited number of *XT4 Crew* staff, please have all of your adult sponsors help *XT4 Crew* enforce each guideline.

Frequently Asked Questions . . .

What time should groups arrive?

The vans for camp will be leaving the designated location on Sunday morning at 9:00 a.m. All campers/counselors are expected at the location by 8:00 a.m. to get checked in, forms picked up, etc. If you are meeting us at Texas Baptist Encampment, onsite registration will be at 4:00 p.m.

What should campers pack?

See the *Things to Bring* list on the *Additional Details* page of this camp *Info Pack*.

How many campers will be assigned to each room?

Girls will be in separate cabins (bunks) and guys will be in separate cabins as well (twin bunk beds) and depending on which cabin determines how many are housed in each.

Will males and females be housed separately?

At all camps, guys and girls will have separate housing.

Are there private bathrooms in each room?

No, there are shared restrooms and showers in each cabin.

Are linens (towels, sheets, pillows, blankets) provided?

No

Will room keys be provided?

No

Are there ice machines at the camp?

No. But if you need ice you can purchase it at the concession stand.

Are there laundry facilities?

No.

Will refreshments be provided between meal times?

No. Three prepared meals a day are provided at each camp. XT4 Crew will provide water at recreation, but campers should bring a water bottle for the cabin. **Liquids are a MUST.** Snack shops with designated hours will have food and drink items for sale.

Are there refrigerators or cooking facilities available at the camp for usage by the groups?

Frequently Asked Questions (page 2) . . .

What are the responsibilities of youth pastors and other adult leaders during camp?

The schedule is designed to allow leaders to "hang-out" with their group and enjoy camp with them . . . leaders will be assigned to camp housing with their students; will participate on the same Rec teams as their students; will eat meals with their students; and will lead their own group's devotional time. All of the on-site planning details are taken care of for the week. We do ask all adult leaders to ensure that their students are on time to events and to enforce the camp guidelines and dress code (see the *Guidelines* and *Camp Attire* pages of this *Info Pack*) during the week.

Who will be the camp praise and worship band?

We will have an exceptional praise and worship band - The Access. Check them out on www.sevenfaith.com.

How can parents contact their students at camp?

See the *Contact Information and Emergency Phone Numbers* section on the *Additional Details* page of this *Info Pack*.

Is there a dress code?

Yes. See the page entitled *Dress Code* in this camp *Info Pack* and please give a copy of the dress policy to each camper before he/she packs for camp.

Will there be a medic/camp nurse on-site?

Yes, we will have a camp nurse. All medicines will be given to the camp nurse on the first day of camp with specific instructions on their dispersion.

Will "in-hours" or "quiet hours" be enforced each night?

Yes. All campers are required to be in their assigned rooms - please check your camp's schedule to find out which time applies to you. At the specified time for each camp, all room lights must be turned out. Adult leaders will be responsible for enforcing this policy with their own groups.

Who will be responsible for policy enforcements?

All adult leaders (youth pastors and counselors) will cooperate with and help enforce all camp policies (including, but not limited to, dress policy, in-hours, opposite-gender room-visitation and on-time expectations to each scheduled event). Please give a copy of the *Camp Policies, Guidelines, and Expectations* page in this *Info Pack* to each camper (adults and students) before departing for camp.

What is the adult to student ratio?

Per State of Texas laws we must have 1 same gender counselor for every 10 campers.

XT4 Crew Camp **Emergency Procedures**

Every counselor and camp leader needs to be informed as to procedures to be followed in the case of emergency. It is not possible to cover all situations completely but leaders should realize that some circumstances call for common sense action. In an emergency the key phrase is "keep calm."

Fire

1. Evacuate building immediately.
2. Move everyone to a safe place and make sure everyone is present. Choose a predetermined place upon arrival to camp.
3. Notify XT4 Crew Camp Directors or Coordinator and Texas Baptist Encampment Staff.
4. Campers should have exits to their dormitory pointed out to them. All dormitories should have directions to exits posted.
5. Campers are encouraged not to use fire extinguishers under any circumstances. The counselor should be responsible for using the extinguishers.

Tornado or Severe Weather

Camp Coordinator will monitor news. If a storm is in the area, the campers should:

1. Go to the Dining Hall and common area of dorms.
2. Counselors will be responsible for orderly evacuation of the dorms and see that all campers are in the Dining Hall or common area of dorms.
3. Cover with mattresses. Stay inside until notified all clear. Stay away from windows and get near an interior wall.
4. If a camper is caught in the open when a storm strikes, they should take cover in a depressed or low area of open ground. Do not get under a tree.

Minor Accident

A minor accident is one in which a doctor's attention is not needed, such as a minor cut, bruise, abrasion, etc.

1. Stay with the injured person
2. Render emergency first aid
3. Move the person to the camp first aid station or summon medical staff.

Major Accident

A major accident is an accident that requires an ambulance, such as a drowning, near drowning, back injury where victim is immobilized, unconscious, severe bleeding or hemorrhaging.

1. Stay with injured person
2. Render emergency first aid
3. Send someone to notify Staff
4. Notify Administrator
5. With the supervision and authority of Camp Nurse, the injured person should be taken to the nearest hospital.
6. Parents or relatives should be notified by XT4 Crew Staff.

Snake Bite

1. Apply a restriction (belt or wide cloth) above and below the bite but not tightly enough to halt blood circulation completely.
2. Keep bitten area lower than the heart if possible.
3. Notify camp staff
4. Transport to the hospital at once.

Africanized Bees

A new danger to areas of Texas is the Africanized bees. Campers should be aware that they should not agitate any swarm of bees. If a swarm is seen, it should be avoided. Someone should be posted to keep other campers from approaching the swarm and someone should go to the camp office to report the swarm.

1. If a camper is stung, they should go immediately to the nurse's station.

Child Abuse

Should a counselor discover evidence of child abuse or sexual molestation, it should be reported to the Camp Director and the Camp Coordinator. Advice on procedures to follow can be obtained by calling the abuse hotline, 1-800-252-5400. We are obligated by law to report all incidents.

Intruders

An intruder is anyone who has not registered at the camp office his/her presence in camp. This may include parents of campers or even church staff. The camp office should be notified if you suspect there is someone in camp that does not belong. Anyone acting suspicious should be reported. One should keep in mind that on family night, great numbers of parents are present and have made arrangements through the camp office. Campers and counselors should not be in remote areas of the camp late at night.

Nurse's Station

All prescription medicines are to be given by the camp nurse. Any counselor who gives medication of any kind to campers is placing himself/herself in a vulnerable position. XT4 Crew is not responsible for the treatment of pre-existing conditions. The nurse's station will be closed after 10:00 p.m. except for emergencies. Campers with head lice or an infectious disease will be sent home. Do not move a camper who has a possible head or spine injury or who is unconscious unless his life is endangered by the circumstances.

Fire-Police-Ambulance: Dial 911

XT4 Crew Dress Code

What to Wear at Camp . . .

All camp attire should be modest and appropriate. This principle applies to **both** sexes.

1. Appropriate and modest clothing must be worn by all students for all events such as worship, teaching sessions, recreation, free time, and all other occasions (general guidelines: mid-riff shirts, tube tops, spaghetti-strap dresses, tank tops, halter tops or mini-skirts may not be worn at camp. Male campers must wear a shirt at all times).
2. Shorts may be worn at all events. Please, no short-shorts or spandex style shorts.
3. Shorts and T-shirts must be worn over swimsuits (except during swim time). Only modest, one-piece swimsuits are acceptable at camp. Two-piece or bikini swimsuits may not be worn at camp.
4. All clothing is subject to *XT4 Crew* staff approval. If the *XT4 Crew* staff feels that an article of clothing is inappropriate, they will ask the student to change immediately.

Rule of Thumb: If it is inappropriate at church, it is inappropriate at camp.

* Youth pastors/leaders, please share these guidelines with parents and campers prior to leaving for camp and help enforce them during our week together. *XT4 Crew* staff members do their best to monitor the dress code, but ask each church to maintain and enforce appropriate standards of modesty.
